Private Duty Home Care Services Hourly and 24/7 Shifts – Live-ins

A person may need short-term or long-term support because of a chronic medical issue or age-related limitations. VNA Northwest Nursing Registry refers caregivers to provide companionship and personal assistance with basic activities such as:

- bathing, personal hygiene, dressing
- eating and food preparation
- medications oversight
- transfers and assistance

The Registry is a non-medical agency and works closely with VNA Northwest or other skilled practitioners to provide a smooth continuum of care. Remaining safe in a comfortable, familiar environment with help from in-home caregivers can significantly enhance client and family quality of life.

As a referral service, we offer–

- a full overview of available levels of care
- a service plan and service agreement to review and sign prior to the initiation of referral services
- a care plan that is developed based on input from client and family
- an opportunity to meet prospective caregivers in advance to build a level of trust and familiarity
- 24/7 after hours On Call staff assistance

Private duty Registry care is provided in the client's home, assisted living facility, skilled nursing facility, hospital - wherever the client calls home.

Private Duty Caregivers Hourly and 24/7 Shifts – Live-ins

Caregivers referred by VNA Northwest Nursing Registry, Inc. are self-employed independent contractors who have been carefully screened, have their own professional liability insurance policy and have demonstrated a high level of compassion and professionalism

Once a successful referral has been made the client directly provides all guidance and direction to the caregiver.

Cost of Private Duty care -

Private duty home care is generally more affordable than transitioning to assisted living facilities or skilled nursing institutions. While some clients have long term care insurance, most individuals receiving private duty home care pay privately, using funds or investments saved for retirement living expenses.

Client and caregiver agree on the rate of pay based on the care needs and the caregiver is paid directly by the client. VNA Northwest Nursing Registry does not set the caregiver hourly rate of pay.

Typical Starting Rates for Caregivers -

Personal Care Assistant	\$17.00/hr. and up
Certified Nursing Assistant	\$18.00/hr. and up
Licensed Practical Nurse	\$30.00/hr. and up
Registered Nurse	\$40.00/hr. and up

VNA Northwest Nursing Registry's *administration fee for each hour of care* received by the client is \$3.80 per hour. This is paid by the client, in addition to the caregiver hourly fee.
